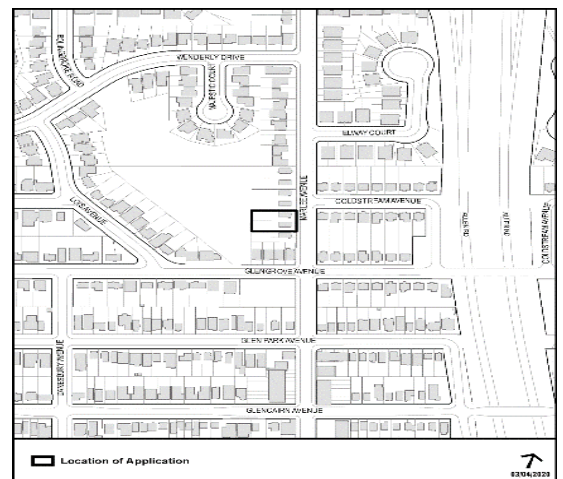

Proposal

The City of Toronto Planning Division has received an Application for Zoning By-law Amendment to permit a four storey (14 metres high) residential apartment building containing 2,174 square metres of gross floor area (GFA) and 28 residential units resulting in a density of 1.56 times the area of the lot (FSI). An on-site parkland dedication of 129 square metres is proposed along the west (rear) end of the site, adjacent to the existing Wenderly Park.

Join us at the Virtual Community Consultation Meeting to participate, which will include:

- an update on the status of the Zoning By-law Amendment application, including its process, and potential outcomes;
- opportunities for local residents, employees, businesses and landowners to provide feedback; and
- next steps for the Zoning By-law Amendment application.
